OGDEN STIRRED OVER FRANCHISE

Personal Interests Crop Out.

Mayor Glasmann Barely Escaped a Warm Roast.

It Is Hoped That He May Some Time Learn the Genesis of Decency.

OGDEN, June 13.—The water franchise now pending before the Ogden City Council are attracting considerable public attention, and the publicity given to the original application of the Ogden Waterworks company through the columns of the Tribune, the first paper to publish the details of the proposed graft, has aroused the public.

The proposition before the Council last evening of the proposed Citizens' Water company brought forth the fire of the concern that has apparently absorbed the control of the water supply of Ogden City, and the too evident interest of Mayor Glasmann in the passage of the compromise franchise submitted to the committee on Laws, and the effort of his committee Friday to have the ordinance pass to its third reading and to final passage was the best evidence the people of Ogden have yet had that the matter was an intended graft.

It became apparent that while the compromise ordinance provided for rates for the Ogden Waterworks company, an Oregon corporation, that cuts in two the rate of the original application, the ordinance would not accept the compromise. This was openly stated in the Council meeting by Councilman Nye.

Was a Body Blow.

The springing of the proposed ordinance to the Citizens' Water company for a franchise to perform the same functions to the citizens of Ogden at rates 50 per cent below those provided in the proposed ordinance for the Ogden Waterworks company, and which Councilman Nye asserted the company would not accept, was a body blow. The application of the Citizens' Water company asks for permission to inaugurate a schedule with a maximum meter rate of 10 cents per 100 gallons and a minimum rate of 3 cents per 100.

The original rate asked for by the Ogden Waterworks company was a maximum in meter rate of 30 cents per 100 and 8 cents minimum. The compromise franchise offered by the Citizens' Water company, and which is stated in open Council would not be accepted by the Ogden Waterworks company, cut the rates in two over the first application, although presented last night were, and are still, 50 per cent higher than those asked for by the Citizens' company.

Why the Compromise?

The question naturally arises, Why is the Ogden Waterworks company, which is asserted the company will decline to accept, and which is 50 per cent higher than the rate asked for by the Citizens' company, objectionable? The answer that is generally given here by those who have a knowledge of the matters and principles involved is that when the Ogden Waterworks company goes into the markets of the world to sell bonds, it can get a higher price for a franchise that earns only half as much as the one that as originally asked for.

Company Has Water.

This has been explained by Rudolph Kuebler. He states that the proposed company owns now some seven to ten feet of water. Some are charitable, and say that "Bill don't know any better." Others express their opinion more openly, and state that Bill's self-interests were the motivating principle.

Roast Waiting for the Mayor.

"The Mayor made his escape with the document just in time," said one citizen this morning. "If he could have been brought back into the Council chamber and made to answer for his conduct, he would have given him some conception of the genesis of decency. President Carr was prepared for him, and Recorder Mitchell will hereafter see that no unauthorized person reaches into his baskets and abstracts therefrom the public principle."

NEW TOWN BOOMING.

Sensational Values at Golden, Nev., Attracts Much Interest.

OGDEN, Utah, June 13.—The new town of Golden, in Nye county, Nevada, is now an actual fact. Emory A. Smith, secretary of the Little Frankie Gold Mining and Smelting Co., has returned to Ogden, Utah, with reports that the prospects for the town are the best ever known in the West. The sensational values obtained from the Little Frankie and from the Argivey company, just across the divide, have attracted the attention of all of the Tonopah and Goldfield population. The result has been an influx of capitalists, who are now investing their money in the Nevada gold fields. Town lots in Golden are in demand and a company will be incorporated to develop the town.

Of the Little Frankie, Mr. Smith says that the tunnel is in now 175 feet, and they have already encountered values that would be expected to be obtained in a tunnel that is now in some 125 feet. He brought back with him some remarkable specimens of crystallized gold in the granite and in porphyry.

It looks as though this new find in Cloverdale canyon, north of Tonopah, was going to attract considerable attention.

COPPER AT NEWFOUNDLAND.
